

# **Guarantors Privacy Notice**

## 1. Overview

We want to explain clearly how we process your Personal Data when you are become a guarantor for a member of our credit union.

To provide our Credit Union services, we need to collect Personal Data relating to our members and their respective guarantors. This privacy notice provides more detailed information about the processing activities of the Credit Union relating to individuals who become a guarantor on behalf of a member of Drogheda Credit Union.

Capitalised terms that are defined in the general Data Protection Statement shall have the same meaning when used in this privacy notice for guarantors.

# 2. Categories of Personal Data

This Privacy Notice provides information relating to the categories of Personal Data we process in relation to guarantors.

When you become a guarantor of a member loan in our credit union, we will process the following data;	
Category of Personal Data	Description
Identification Data	This includes your name, identification documents, passport/driving license,
	signatures.
Contact Data	This includes email address, phone number, postal address.
Financial Data	This includes financial data such as salary, occupation, accommodation
	status, credit history.
Correspondence Data	If you interact with us, we will record details of those interactions. For
	example, we will process details of phone calls, email correspondence and
	hard copy correspondence.

## 3. Processing Activities

We need to process this information to make sure we can comply with our legal obligations and contractual requirements, the data helps in;

- Assessing the loan application and determining your creditworthiness for the loan in your capacity as guarantor.
- Conducting due diligence/credit checking.
- We may use credit scoring techniques and other automated decision-making systems to either partially or fully assess the application in your capacity as guarantor.
- To comply with Central Bank Regulations to determine whether you are a connected borrower or related party borrower.
- To ensure repayment of the loan and to facilitate the requirements of the contract between you and Drogheda Credit Union.



- To contact you in respect of your guarantee in the event of the change of circumstance of the member getting into arrears.
- Collection of the debt.

We need the information in the list above to allow us to record your details as guarantor, identify you, to contact you and seek repayment of the loan you have guaranteed.

Some of the above grounds for processing will overlap and there may be several grounds which justify our use of your personal data.

The lawful basis upon which we rely for processing the above information is Legal Obligation and Contract.

## How we may share the information

We may also need to share some of the above categories of personal information with other parties, such as the Irish League of Credit Unions (ILCU)<sup>1</sup> and our professional advisers such as solicitors or auditors. Usually, information will be anonymised, but this may not always be possible. The recipient of the information will be bound by confidentiality obligations. We may also be required to share some personal information with our regulators or other third parties (such as persons administering the deceased estate) as required to comply with the law.

#### Transfer of data outside the EEA

We do not process any of your personal data outside the European Economic Area (EEA) and we make it a condition of our processors who work for us under contract that they must process your data on our behalf within the EEA also. Data may be transferred from us to the UK which is a third country. The data is transferred based on an adequacy regulation by the EU in respect of the UK.

## 4. Sources of Personal Data

We ask you to provide the required information directly to us to help us in assessing the loan application.

## 5. Retention of member information

We only keep your Personal Data as long as it is necessary for the purposes of processing it or to comply with legal or regulatory requirements.

We document the reasons for our retention periods and where possible the retention periods themselves in our internal Retention Policy. Your details will be held for seven years following default of the borrower, date of demand, discharge, transfer, or repayment of the loan.

Once the retention period has expired, the respective data will be permanently deleted.

Note that this privacy notice relates only to how we process data relating to member accounts.

# **Your Rights**

Irish legislation and the EU's General Data Protection Regulation gives individuals significant rights over how their personal data is collected and used. A summary of these rights is set out below. Further information can be found on the website of the Data Protection Commissioner (<a href="https://www.dataprotection.ie">www.dataprotection.ie</a>).

Q	• To find out whether we hold any of your personal data, if we do, to request access to that data that to be furnished a copy of that data. You are also entitled to request further information about the processing.
<b>1</b>	• Request correction of the personal information that we hold about you. This enables you to have any incomplete or inaccurate information we hold about you rectified and kept as up to date and as accurate as possible.
×	• Request erasure of your personal information. This enables you to ask us to delete or remove personal information where there is no good reason for us continuing to process it. You also have the right to ask us to delete or remove your personal information where you have exercised your right to object to processing (see below).
	• Object to processing of your personal information where we are relying on a legitimate interest (or those of a third party) and there is something about your particular situation which makes you want to object to processing on this ground. You also have the right to object where we are processing your personal information for direct marketing purposes.
RESTRICTIONS APPLY	Request the restriction of processing of your personal information. You can ask us to suspend processing personal information about you, in certain circumstances.
Withdraw	• Where we are processing your data based solely on your consent you have a right to withdraw that consent at any time and free of charge.
	• Request that we: a) provide you with a copy of any relevant personal data in a reusable format; or b) request that we transfer your relevant personal data to another controller where it's technically feasible to do so. 'Relevant personal data is personal data that: You have provided to us, or which is generated by your use of our service. Which is processed by automated means and where the basis that we process it is on your consent or on a contract that you have entered into with us.

If you have any questions or queries, please feel free to contact the Data Protection Officer in Drogheda Credit Union who is there to help answer your questions and make sure your data is processed carefully and correctly.

You always have the right to seek advice and support from the **Data Protection Commissioner (DPC)** and make a complaint where you believe we have breached your rights in the processing of your data.

# Please note that the above rights are not always absolute and there may be some limitations.

You are free to submit a Subject Access Request to Drogheda Credit Union free of charge and within 30 days the Data Protection Officer will provide you with copies of your personal data which Drogheda Credit Union process and supporting information such as the source of your data, retention periods and who your data has been share with, if anyone. There is no charge and such a request.



If you want access and/ or copies of any of your personal data or if you want to review, verify, correct, or request erasure of your personal information, object to the processing of your personal data, or request that we send you or a third party a copy your relevant personal data in a reusable format please contact our Data Protection Officer in writing using their contact details above.

There is no fee in using any of your above rights, unless your request for access is clearly unfounded or excessive. We also reserve the right to refuse to comply with the request in such circumstances.

We may need to verify your identity if we have reasonable doubts as to who you are. This is another appropriate security measure to ensure that personal data is not disclosed to any person who has no right to receive it.
